Dear Consultee

Consultation on the proposal to change the age range of York Road Nursery School, Hitchin by altering the lower age limit to enable the school to offer nursery provision to 2-year-old children from 2 September 2019

We are writing to consult you on a proposal to change the age range of York Road Nursery School (a community school), York Road, Hitchin, Hertfordshire, SG5 1XA (“the school”) by altering the lower age limit. This will change the age range from 3 to 5 years to 2 to 5 years, enabling the school to start offering places to 2-year-old children from 2 September 2019.

This proposed change of age range is a ‘prescribed alteration’ which requires Hertfordshire County Council, as the proposer, to follow a statutory process, which will include a public consultation. We would therefore like to hear your views on this proposal.

Why is this being proposed?

By lowering the admission age of the school, we can ensure that 2-year-old children in the community, particularly the most vulnerable, are able to access the free place that they are entitled to. The take-up of the entitlement for 2-year-old children in this locality is lower than the county and national average. The ability of the school to offer this entitlement from September 2019, combined with effective marketing and a good working relationship with York Road Family Centre, will ensure that families are offered this provision, and increased awareness of the offer will stimulate demand and increase take-up.

Currently the nursery has capacity for 96 children in the morning and 88 children in the afternoon including children accessing the day care on site; it is proposed that this number will not change, but 12 of the children will be 2-year-olds.

There is a surplus of places across the maintained and private, voluntary and independent (PVI) childcare sector in this locality for 3 and 4-year-olds and the school have confirmed that there are 92 children¹ of this age attending the school at present. Therefore, it is not anticipated that lowering the admission age to the age of 2, will have a negative impact on children aged 3 and 4.

Children access either a morning or afternoon session, each running for 3 hours. The school has sufficient and suitable space to accommodate 2-year-old children. Therefore, no additional spaces or buildings are required to implement this proposal.

The proposed change of age range will bring the school in line with the vast majority of other maintained nursery schools in the county which admit children from the age of 2.

Have your say.
