Dear Parents and Carers,

I do hope you all managed to have a good break and I wish you all a very happy new year.

As you have no doubt been following in the news, positive cases of covid19 in Hertfordshire are rising. All secondary schools will be closed at the start of term. The current situation is that our school will open again to all pupils on Tuesday 5th January. However, you will have seen in the press that there are calls for all schools in Tier 4 areas to switch to remote learning for a short period so please have contingency plans in place as you may be advised at short notice that your child is to stay at home.

If this were to happen then our teachers will be working really hard to ensure that the home learning provision is of a very high standard. We will, however, be required to provide places in school for children of critical workers and any children deemed vulnerable. Any switch to home learning is likely to be for a short period of time and the in-school provision will follow the home learning that teachers are setting.

We asked you a few weeks ago to let us know if you are a key worker, if your situation has changed or if you have recently become a key worker, please let us know so that we can plan for any required critical worker in school provision accurately (for either now or in the coming months), please can you look at the critical worker list below to see if your employment falls into this. If, in the event of a switch to remote learning, your child would need and qualify for a place at the in school critical worker provision, please email into the office team on admin@yorkroad.herts.sch.uk

We ask that if we do move to home learning that you only bring your child in to school on the actual days that you are working and not if you are at home.

Should the situation remain the same, we look forward to welcoming all the children tomorrow and for our new children who start on Wednesday. We have been very successful in school so far with infection control and have had only had to close our school once in 10 months. We will continue to do all that we have been doing to keep your children safe and happy and as such all our systems and processes from last term will continue.

Every single one of us now has an increased responsibility to make sure that we are following the guidance around social distancing and not mixing with people outside of our bubbles. At York Road we are proud to be one bubble, all looking after each other.

Critical Worker List:

Parents whose work is critical to the coronavirus (COVID-19) response include those who work in health and social care and in other key sectors outlined in the following sections.

Health and social care

Doctors, nurses, midwives, paramedics, social workers, care workers, and other frontline health and social care staff including volunteers

the support and specialist staff required to maintain the UK's health and social care sector

those working as part of the health and social care supply chain, including producers and distributors of medicines and medical and personal protective equipment

Education and childcare

registered childcare

support and teaching staff

social workers

specialist education professionals who must remain active during the coronavirus (COVID-19) response to deliver this approach

Key public services

those essential to the running of the justice system

religious staff

charities and workers delivering key frontline services

those responsible for the management of the deceased

journalists and broadcasters who are providing public service broadcasting

Local and national government- This only includes a) or b)

- a) those administrative occupations essential to the effective delivery of the coronavirus (COVID-19) response
